

## **INFORMATION CLAUSE IN CASE OF COLLECTION OF DATA FROM THE DATA SUBJECT**

Pursuant to Article 13(1) and (2) of the Regulation (EU) 2016/679 of the European Parliament and of the Council of 27.04.2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (Official Journal of the EU L 119, p. 1) (hereinafter: "RODO"), I inform you that:

### **1. The personal data administrator**

The administrator of your personal data is Export Pack Polska Spółka z ograniczoną odpowiedzialnością & Co. spółka komandytowa with its registered office in Zabrze, address: 6 Alberta Borsiga Street, 41-807 Zabrze, entered in the register of entrepreneurs of the Krajowy Rejestr sądowy held by the Sąd Rejonowy in Gliwice, X Wydział Gospodarczy under the number KRS 0000695634, NIP: 6482784746, REGON: 368445100 (hereinafter also referred to as the "Company"), represented by the General Partner: Export Pack Polska Spółka z ograniczoną odpowiedzialnością, on behalf of which acts the President of the Board - Łukasz Pietrzyk.

### **2. Purpose and legal basis for the processing of personal data**

Your personal data will be processed in order to perform the contract concluded with the Company, on the basis of Article 6(1)(a) of RODO, i.e. your consent to the processing of personal data.

### **3. Obligation/voluntariness of providing personal data**

The provision of personal data by you is voluntary and constitutes a condition for the conclusion and performance of the Contract.

### **4. Duration of data processing**

Your personal data shall be stored for the duration of the Contract and the period resulting from the relevant provisions of law.

### **5. Recipients of personal data**

The recipients of your personal data shall be: an accountant's office keeping the Company's accounts, a law firm providing legal services to the Company, an entity providing transport services - in the event that the Administrator is commissioned with transport of the Products, and an entity with which the Administrator has concluded a contract on insurance of civil liability for property ownership and business activities in the event that you suffer damage in connection with the performance of the contract.

## **6. Rights of the data subject**

Under the RODO, you have the right to:

- request access to your personal data
- request correction of your personal data
- request the erasure of your personal data
- request the restriction of the processing of your personal data
- object to the processing of your personal data
- request the portability of your personal data

## **7. Right to withdraw consent**

You may withdraw the consent you have given for the processing of your personal data at any time. Your withdrawal of consent to the processing of your personal data shall not affect the lawfulness of the processing carried out on the basis of your consent before its withdrawal.

## **8. Complaint to the supervisory authority**

You have the right to lodge a complaint to the supervisory authority, i.e. the President of the Office for Personal Data Protection (PUODO).

## **9. Legitimate interests pursued by the controller or a third party in connection with the performance of obligations arising from the contract.**
